

Exciting Updates to the Neighborhood Assistance Program

GREAT NEWS!

On July 11, 2024, Governor Josh Shapiro signed into law the 2024-25 state budget, bringing significant changes to the Neighborhood Assistance Program (NAP) that affect applications submitted between May 3 and June 28, 2024. One of the most impactful changes is the increase in the total available tax credit awards, which has doubled from \$36 million to \$72 million. This enhancement provides a substantial boost to the program, enabling more funds to be directed toward community development projects.

In addition to the increased funding, the tax credit percentages have also been revised. The Special Program Priorities (SPP) tax credit rate has been raised from 75% to 90%. This change significantly enhances the value of contributions made through the NAP. For example, under the previous rate, a \$10,000 contribution would yield a \$7,500 tax credit. With the new rate, the same \$10,000 contribution now generates a \$9,000 tax credit. This adjustment effectively reduces the net cost of the donation from \$2,500 to just \$1,000, making contributions even more attractive and impactful for donors.

We want to express our heartfelt gratitude for your initial contributions and continued support. The changes to



the NAP provide an opportunity for donors to maximize their impact. If you wish to adjust your contribution amount in light of the increased tax credit rates, you will need to submit a new commitment letter stating the revised amount. The new commitment letters are due by August 12, 2024, and the template is attached in the email. If you choose not to make any adjustments, please know that we are deeply thankful for your support as it stands.
